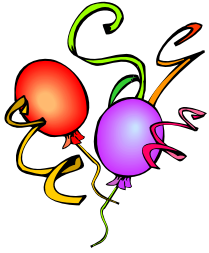


HAVE YOUR BIRTHDAY PARTY AT

A copy of this contract must be returned, in addition to your \$100 deposit, before your party can be booked in our calendar. The cost of the birthday party package is \$175.00. Also included in the price are two cheese pizzas, two pitchers of soda, 10 ice creams and one table reservation.

Birthday Party Guidelines and Procedures:

- On the day of your party please call our office to reconfirm your reservation prior to 12:00 noon.
- Birthday parties are reserved from 3:00-7:00pm. You will not be allowed into the park until 3:00pm. No exceptions!
- If there is a line at the admissions window please have one guest from your party alert the cashiers that your party has arrived.
- Please provide an invite list (typed) to our cashiers on the day of your party.
- Each party is allotted 8 children and 2 adults. Extra children are \$7.00 and extra adults are \$8.00. (Everyone attending the party will be charged). Parties of 15 or more MUST book a second table.
- You and your guests will be escorted to our birthday party pavilion.
- If you have purchased a single party you will have one picnic table reserved. If you have purchased a double party you will have two picnic tables reserved.
- A birthday cake or cupcakes, water, and goodies bags are the only outside food and drink items you are allowed to bring into the park.
- We will provide plates, cups, forks, spoons, and a tablecloth for the appropriate number in your party.
- You will speak with a manager of the snack bar to arrange for your food. Any extra food will be purchased and paid for at the snack bar.
- Settle any outstanding balances with our cashiers no later than 6:30pm on the evening of your party.
- It is requested that you clean up your birthday party area prior to departure.

Inclement Weather Policy:

- Be aware that inclement weather may cause the CBWP to shut down on the day of your party. Although the weather may be suitable during the hours of your party, a decision to open must be made early in the day.
- A manager will notify you in the event of a park closure.
- If the CBWP closes for the day of your party, you will be offered the opportunity to pick another date.
- If the CBWP closes during your party, and you have already ordered and received your food, no rain date or refund will be offered.
- If the weather is rainy or chilly during your party, but the Waterpark does not close for the day, you will not be issued a rain date or a refund.
- Management reserves the right to close for any reason.
